MOST CHILDREN COME TO HORTON'S KIDS SIGNIFICANTLY BEHIND, ESPECIALLY IN LITERACY. IN COMMUNITES LIKE THE ONES WE SERVE, THIS GAP HAS WIDENED AS THE COVID-19 PANDEMIC HAS CONTRIBUTED TO AN AVERAGE OF FIVE MONTHS OF UNFINISHED LEARNING IN LITERACY AND MATH. WE ADDRESS THE EQUITY GAP THROUGH RESEARCH-BACKED HIGH-INTENSITY TUTORING, HOMEWORK HELP, AND LITERACY INTERVENTIONS. YOUTH PROGRAMMING FOR HIGH SCHOOL STUDENTS INCLDES CAREER EXPLORATION AND SAT AND ACT PREPARATION TO PREPARE THEM FOR POST SECONDARY OPTIONS. WE ALSO WORK CLOSELY WITH CAREGIVERS TO BUILD STRONG RELATIONSHIPS BETWEEN THEM AND THEIR CHILDREN'S SCHOOL. IN PARTICULAR, WE HELP CONNECT FAMILIES WITH (CONTINUED ON SCHEDULE O)
